**CONTRIBUTOR AGREEMENT**

Agreement dated August 25, 2010, between **Lawrence Hubert** (hereinafter called the Author) and **Routledge** (a member of the Taylor & Francis Group), 270 Madison Avenue, New York, NY 10016 (hereinafter called the Publisher) whereby it is mutually agreed as follows:

1. The Author hereby agrees to contribute a chapter (hereinafter called the Contribution) to the following volume:  
  
*Handbook of Ethics in Quantitative Methodology* (hereinafter called the Work) edited by **Abigail T. Panter & Sonya K. Sterba** (hereinafter called the Editor) consisting of no more than 70 typed, single sided, double-spaced manuscript pages, including tables, figures, references and end notes. If the final manuscript exceeds this length, the Publisher reserves the right to require the Author to make cuts.
2. The Author agrees to grant and assign exclusively to Routledge all rights of whatsoever kind, including copyright, in the Contribution, and every part thereof, during the full term of copyright in the United States of America and elsewhere. Routledge will secure copyright protection for the contribution by registering the Work in the name of Routledge in accordance with the requirements of the copyright law of the United States.
3. The Author represents and warrants to Routledge that the Contribution is original and that he/she has full power to make this agreement; that the Contribution has not been previously published, in whole or in part, except as you have advised Routledge in writing; that the Author has used all reasonable care to ensure that all facts and statements in the Contribution are true; and that the Contribution is not defamatory, obscene, or violative of any right of privacy, common law, or statutory copyright or other personal or property rights. The Author agrees to hold Routledge harmless from any claim made against it which, if sustained, would constitute a breach of the foregoing warranties.
4. The Author agrees to obtain promptly, at his/her expense, any permissions necessary for reprinting in the Contribution material under copyright or for reproducing illustrations, charts, drawings, diagrams, or other illustrative matter under copyright, and to transmit such permissions in writing to the Editor with the final copies of the manuscript.
5. The Author agrees to deliver to the Editor no later than **September 1, 2010**, one legible typewritten copy of your contribution, in form, style, and content satisfactory to the Editor and to Routledge. The manuscript, including extracts, notes, bibliography, and legend copy, shall be double-spaced throughout. With the manuscript the Author agrees to deliver to the Editor all illustrative materials prepared in a form that is, in the judgment of Routledge, suitable for photo reproduction.

6. The Author agrees to read, correct, and promptly return to the Editor all proofs of the Contribution sent to the Author at the discretion of the volume Editor. In the event of the Author's failure to return proofs by the deadline set by the Editor, Routledge shall be free to proceed with the manufacture and publication of the Work without the Author's corrected proofs. The Author agrees that the Editor may, at his or her discretion, disallow any or all of the Author's alterations in proofs that are not solely corrections of errors made by Routledge or the compositor.
7. The Author understands and agrees that all details of publishing the Contribution shall be under the control of Routledge and shall be governed by the contract between Routledge and the Editor of the Work.
8. Upon publication of the Work, Routledge grants the Author an irrevocable, nonexclusive, royalty-free license to use the Contribution in any volume consisting wholly of the Author's own work, provided that (a) the Author furnishes prior written notice of each such use to Routledge and that (b) each such use shall carry the copyright notice specified to you in writing by Routledge.
9. Routledge shall give each Author one free copy of the Work. The Author may purchase additional copies for his/her own use at a discount of 25 percent from the prevailing retail price.
10. It is agreed that the Contribution will be written to the satisfaction of the Editor.
11. You agree that you will receive no royalty under this Agreement.


## ADDENDUM TO CONTRIBUTOR AGREEMENT

PUBLISHER AND AUTHOR AGREE THAT WHERE THERE ARE CONFLICTING TERMS BETWEEN THE Contributor AGREEMENT AND THIS ADDENDUM, THE PROVISIONS OF THIS ADDENDUM WILL BE PARAMOUNT. IN ADDITION TO THE RIGHTS GRANTED THE AUTHOR IN THE PUBLICATION AGREEMENT AND BY LAW, THE PARTIES AGREE THAT THE AUTHOR SHALL ALSO RETAIN THE FOLLOWING SPECIFIED RIGHTS:

1. The Author shall, without limitation, have the non-exclusive right to use, reproduce, distribute, and create derivative works including update, perform, and display publicly, the Article in electronic, digital or print form in connection with the Author's teaching, conference presentations, lectures, other scholarly works, and for all of Author's academic and professional activities.
2. After a period of eighteen (18) months from the date of publication of the article, the Author shall also have all the non-exclusive rights necessary to make, or to authorize others to make, the final published version of the Article available in digital form over the Internet, including but not limited to a website under the control of the Author or the Author's employer or through digital repositories including, but not limited to, those maintained by CIC institutions, scholarly societies or funding agencies.
3. The Author further retains all non-exclusive rights necessary to grant to the Author's employing institution the non-exclusive right to use, reproduce, distribute, display, publicly perform, and make copies of the work in a password protected electronic format accessible only to individuals associated with the institution or in print form in connection with teaching, conference presentations, lectures, other scholarly works, and all academic and professional activities conducted at the Author's employing institution.

THIS ADDENDUM AND THE CONTRIBUTOR AGREEMENT, TAKEN TOGETHER, CONSTITUTE THE FINAL AGREEMENT BETWEEN THE AUTHOR AND THE PUBLISHER WITH RESPECT TO THE PUBLICATION OF THE ARTICLE AND ALLOCATION OF RIGHTS UNDER COPYRIGHT IN THE ARTICLE. ANY MODIFICATION OF OR ADDITIONS TO THE TERMS OF THIS AMENDMENT OR TO THE PUBLICATION AGREEMENT MUST BE IN WRITING AND EXECUTED BY BOTH PUBLISHER AND AUTHOR IN ORDER TO BE EFFECTIVE.
